- There will be a Dual Primary, June 8, 2021. We will know by March whether or not it will be moved to the third week of June.
 - Not clear about whether City Council Elections will be moved to Fall of 2022.
 - Budget Bill has included salary compensation at the Constitutional Officer level for Registrars.
 - Prohibition of carrying a firearm within 40 feet of polling place passed, on Governor's desk.
 - Absentee and Early Voting on Sundays contested among Registrars.
 - Pre-registration at 16 years of age or older
2. RISK-LIMITING AUDIT RESULTS: Completed (Results not yet available; Meet today in Richmond).
3. MINIMUM SECURITY STANDARDS for the Williamsburg Registrars is up-to-date with City I.T.'s help.
4. Website is updated.

Officers of Election. Covid vaccine requirement? Expected low volume for a dual primary.


Concern about aggressive Poll Watchers. Harassment by poll watchers was a significant matter in last election.
