Sponsorship Regulations

The Williamsburg Parks & Recreation Department (“WPRD”) will not accept sponsorship materials that are disparaging, disrespectful or disreputable to persons, groups, businesses or organizations, including promotions that portray individuals as inferior, evil or contemptible because of their race, color, creed, age, marital status, disability, national origin, ethnic background, religion, sexual orientation, gender, or any other characteristic protected under federal, state or local law.

WPRD will not accept sponsorship materials that are false, misleading, libelous, deceptive or fraudulent.

WPRD shall only accept sponsorships that it deems in its sole discretion that are appropriate to display during activities for children and youth. Consequently, WPRD will not accept sponsorships that advertise products or promote activities that are deemed by WPRD, in its sole discretion, to be harmful, unhealthy, unwholesome or otherwise deleterious to children, including but not limited to the following:

- a. WPRD will not accept sponsorships that relate to an illegal activity or propose a commercial transaction that is prohibited by federal, state or local law, regulation, or ordinance for the localities and partners served by the Department.
- b. WPRD will not accept sponsorships that contain explicit or suggestive sexual material, obscene material, or material harmful to minors as those terms are defined in Virginia Code §§ 18.2-372 *et seq.*
- c. WPRD will not accept sponsorships for X-rated movies, sexually oriented businesses, adult bookstores, escort services, pawn shops, tattoo parlors, check cashing or similar services, or massage parlors, except that clinical facilities of a licensed and certified massage therapist pursuant to title 54.1 of the Code of Virginia or other salons or day spas in which massage therapy is offered as one service in addition to numerous other cosmetology services may be considered as sponsors.
- d. WPRD will not accept sponsorships for tobacco or tobacco-related products. Anti-tobacco advertising is acceptable.
- e. WPRD will not accept sponsorships for alcohol or alcohol-related products. Anti-alcohol promotions, such as the Virginia ABC campaign “None for the Road” is acceptable.
- f. WPRD will not accept sponsorships for illegal drugs, illegal drug paraphernalia, or legal drugs with sexual connotations.
- g. WPRD will not accept sponsorships for the sale or use of firearms and other weapons.
- h. WPRD will not accept sponsorships that depict violence and will not accept sponsorships that advocate violence of any kind.
- i. WPRD will not accept sponsorships that advocate participation in gangs, cults, or the occult.
- j. WPRD will not accept sponsorships that include language that is obscene or profane.

WPRD will not accept sponsorships for political campaigns, political issues, issue advocacy, public interest, or public service campaigns.

Medical products or treatments sponsorships are to be treated in a restrained and inoffensive manner as determined by the Parks & Recreation Director.

All materials that promote contests or giveaways must comply with all applicable laws and regulations.

WPRD reserves the right to use any sponsorship space for department and other government announcements and information until such space is sold to sponsors.

All sponsorship eligibility decisions determined by the Parks and Recreation Director are final.
