

**Enforcement Concerns, Special Events and  
Emergency Parking Contact:**

The Police Department at 757-220-2331 for parking needs to accommodate events, such as weddings, funerals, etc., and also in circumstances involving impaired health or old age, or temporary care of a nurse or other attendant.

***Be Aware!***

- (1) *Sale or conveyance of City parking permits to a third party in exchange for consideration of any kind is a Class 2 misdemeanor.*
- (2) *Display on a motor vehicle of any decal or permit issued in violation of City Code Division 5 is a Class 3 misdemeanor.*
- (3) *Allowing the use of any parking permit for any purpose for which it was not issued is a Class 4 misdemeanor.*
- (4) *The City may revoke any permits issued to any person who uses or allows the use of parking permits in a manner inconsistent with those uses authorized pursuant to City Code Section 11-250.*

# Resident Parking Permits

**Purpose** - Parking permits are required on vehicles for certain residential City streets, due to limited parking spaces. Residents are entitled to purchase one Resident Parking permit for each of their registered vehicles.

**Purchase** - Parking permits are sold at the City of Williamsburg Municipal Building Finance Department, 401 Lafayette Street, 757-220-6180. All permits expire August 31st each year. New permits are available for purchase annually on August 1st. The cost for each permit is \$5.

**Eligibility** - Owners or tenants living on streets designated "Resident Parking" may purchase parking permits. Current DMV registration(s), and a **hard copy signed lease** if the vehicle is not registered to the resident parking address; must be presented at the Finance office for issuance of resident and/or guest parking permits. **Vehicle(s) must be registered in tenant's name or immediate family member name.**

**Display** - Resident Parking permits are displayed on the vehicle's left rear bumper. Motorcycles may display decals on a front fork, rear shock, fender or oil/battery cover.



Decals shall not be transferred from one vehicle to another. All out-dated permits are to be removed from vehicles.

**Guest Parking** - Owners or tenants of a property containing only one single family dwelling unit are entitled to purchase up to 2 Guest Parking permits. Owners or tenants of a property containing more than one dwelling unit can purchase 1 Guest Parking permit for each dwelling unit located on the property.

- Permits are for the exclusive use of non-resident visitors of the property address for which assigned.
- Non-resident is considered a short-term basis; otherwise, the individual or vehicle must qualify under the resident guidelines.
- Should you move before the guest permit(s) expire, please be sure they remain at the dwelling.

**Tourist Parking** - Owners of single family dwellings legally renting rooms to transient guests or tourists may obtain a Tourist Permit on the basis of one permit per room rented.

**Enforcement - PARKING PERMITS ENTITLE USERS TO PARK NEAR THE STREET ADDRESS FOR WHICH THEY ARE PURCHASED.** Guest Parking permits display the street name & address on the hanging tags, and likewise, are valid only for parking near the home address. The Williamsburg Police Department strictly enforces permit parking regulations. Fines are \$10 for 1st offense, \$35 for 2nd offense, \$50 for 3rd offense, \$100 for 4th offense & \$300 thereafter **within a calendar year**. In addition, late fees for payments not made within 11 calendar days will apply. **If you suspect abuse of parking permits in your neighborhood** - call 757-220-2331.

**Exemptions** - Service or delivery vehicles while operating in regulated areas; and autos, motorcycles and pickup trucks may park in regulated areas for up to 4 hours per day on Saturdays and Sundays.
