8 INDIVIDUALS ARRESTED AS A RESULT OF A NARCOTICS INVESTIGATION

Williamsburg, VA – The Williamsburg Police Department and the Tri-Rivers Drug Task Force have concluded the first phase of a months-long undercover investigation with a narcotics round-up which resulted in eight individuals being arrested and charged with narcotics distribution/possession offenses.

Drugs seized during this investigation included Cocaine, Crack Cocaine, Methamphetamine, THC Oil, and Marijuana. We also recovered one (1) firearm.




The criminal investigation began when investigators received information from community members that individuals were delivering illegal narcotics to our city. This information fueled the criminal investigation which targeted the illegal drug activity. This is an ongoing effort and we anticipate additional charges in the future.


Williamsburg Police Chief Sean Dunn is appreciative of all community partners involved. “We are thankful that we have community members that trust us enough to share this type of information with the police so that together, we can make our community a safer place for all. I commend these courageous citizens. I would also like to express my appreciation for the steadfast efforts by our investigators and the assisting Tri-Rivers Drug Task Force members whose brave efforts allowed us to develop charges and make apprehensions without incident.”
